## PURPOSES AND LEGAL BASIS FOR PROCESSING PERSONAL DATA

Your personal data will be processed by the Administrator for the following purposes: a) To enable you to use the website <a href="https://zubau.com/">https://zubau.com/</a> (hereinafter: "Service") and the services provided by the Data Controller through it (the legal basis for processing is Article 6(1)(b) of the GDPR);

- b) To manage the registration process in the Service, i.e., the activity of creating an account as a Service user (hereinafter: "User"), logging into the User's account, or pursuing claims (the legal basis for processing is Article 6(1)(b) of the GDPR);
- c) To prevent fraud, including money laundering and other illegal activities (the legal basis for processing is Article 6(1)(c) of the GDPR);

# **DATA RETENTION PERIOD**

Data required to fulfill legal obligations will be retained for as long as required by law — legal basis under Article 6(1)(c) of the GDPR or for the period during which SARL TOP MONAKO may bear legal consequences for non-fulfillment — legal basis under Article 6(1)(f) of the GDPR.

### **DATA SUBJECT RIGHTS**

You have the right to access your personal data, request correction, deletion, portability, or restriction of processing, as well as the right to withdraw consent.

## RIGHT TO OBJECT

You may object to the processing of your personal data at any time, where the legal basis for processing is the legitimate interest of the Administrator or the public interest. In this case, upon reviewing your request, SARL TOP MONAKO will no longer process your data unless there are legitimate grounds for further processing or for the establishment, exercise, or defense of legal claims.

### RIGHT TO LODGE A COMPLAINT WITH A SUPERVISORY AUTHORITY

You have the right to lodge a complaint with the supervisory authority, should you believe that the processing of your personal data violates legal provisions.
