

## **Terms of Use of the Website <https://zubau.com/>**

### **1. General Provisions**

1.1. These terms and conditions define the rules for using the "ZUBAU" website available at <https://zubau.com/>, hereinafter referred to as the "Website".

1.2. The owner of the Website and the service provider is SARL TOP MONAKO, with its registered office in Monaco, holding the RCI number ("Trade and Industry Register") 23 S 09495 and VAT number FR94000180124, located at Château Périgord I (Socle), 6 LACETS SAINT LEON, 98000 Monaco, with a share capital of 15,000.00 Euros, hereinafter referred to as the "Administrator".

1.3. A user of the Website is any natural or legal person who uses the Website, hereinafter referred to as the "User".

### **2. Rules of Use**

2.1. On the Website, Users have the opportunity to browse available e-books after entering a promotional code.

2.2. To use the services offered on the Website, the User must have an active promotional code that entitles them to access specific e-books.

2.3. Each promotional code has a specified validity period, after which it expires and cannot be reused.

2.4. Promotional codes may not be sold, exchanged, or transferred to third parties without the Administrator's consent.

### **3. Conditions for Using E-books**

3.1. After entering a valid promotional code, the User gains access to specific e-books, which can be read directly on the Website.

3.2. The e-books available on the Website are protected by copyright. The User is entitled to use them exclusively for personal use. Any copying, distribution, public sharing, or modification of the e-book content without the consent of the Administrator or the copyright holder is prohibited.

3.3. The User is not entitled to download e-books unless otherwise decided by the Administrator.

### **4. Liability**

4.1. The Administrator is not responsible for any interruptions in access to the Website resulting from technical reasons, maintenance, or circumstances beyond the Administrator's control.

4.2. The Administrator is not liable for damages arising from the improper use of promotional codes by Users.

4.3. The Administrator reserves the right to temporarily or permanently block access to the Website for Users who violate these terms and conditions.

### **5. Privacy Policy and Data Protection**

5.1. The Administrator processes Users' personal data in accordance with applicable laws and the Privacy Policy, available at [https://zubau.com/privacy\\_policy\\_en.pdf](https://zubau.com/privacy_policy_en.pdf).

5.2. By using the Website, the User agrees to the processing of their personal data for the purpose of providing services offered by the Website.
